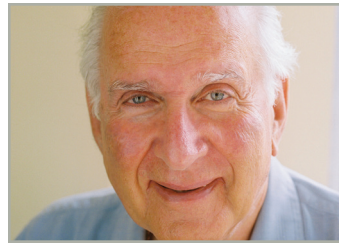

Evans Award of Community Distinction and in 2013, the Governor General of Canada presented Bill with a Queen Elizabeth II Jubilee Medal honouring significant contributions and achievements by Canadians. He has also been named to Hamilton's Gallery of Distinction in recognition of his lasting contributions to the city of Hamilton.

Bill gives tirelessly of his time to many worthwhile organizations. He has served as President of the Hamilton Law Association, President of the Hamilton Medical- Legal Society, President of the Hamilton Jewish Federation Canada, President of the League for Human Rights of B'nai B'rith Canada, and President of B'nai B'rith.
